Please Note:

- All Junior Sailing and Racing Teamclass fees and forms are due before: **April 1, 2010, but we confirm on a first come, first serve basis as soon as we receive your application.**
- New applications to the sailing program are processed in the order in which they are received, as determined by the postmark.
- Junior sailors who are returning for a consecutive season will be shown enrollment priority **only** if their forms are received by the April 1st deadline. After that date, it will be considered a “new” application to the sailing program.
- Discount applies **only** to “sailing school and racing team” tuition, and **does not** apply to membership dues. Tuition for Sailing & Racing is lower if you are an active member of AYC.
